

## On **HIV** - **H**uman **I**mmunodeficiency **V**irus

Some years ago, Voice of America beamed short-wave broadcasts on science to South Africa. One of its transmitted articles, way back then, was on a report of experiments dealing with "removal" of all **HIV** from afflicted persons who previous to treatment were continuously testing positive. VOA reported previous studies had generated a finding **HIV** caused **AIDS**.

The article revealed in a select group of persons positive with **HIV** [but not yet **AIDS**] a special blood circulating apparatus was run on each of them. The apparatus was composed of a machine routinely used during heart surgery with certain components and procedures added:

- 1) A controlled heater to raise and hold the temperature of the incoming blood from the person to a certain temperature quoted as about 20 degrees F above normal.
- 2) Ability of the apparatus to hold the "hot" blood at that elevated temperature beyond a certain period of time.
- 3) Thereafter, the "hot" blood was passed thru a virus filter to trap **HIV**.
- 4) Down stream from the filter, the blood was cooled to normal body temperature.
- 5) The down stream cooled blood was then returned back into the person.
- 6) The blood circulation through the apparatus continued beyond a certain period of time, until the person tested **HIV** negative for an extended period of time.

Previous to the above experiments, in various labs around the planet, including those in the USA, it was learned **HIV** occupies pockets located on the surface of white blood cells.

**AIDS** occurs because most, if not all, pockets on all white blood cell are filled with **HIV**. White blood cell pockets then can not hold any more virus and can not fight off an invading virus and bacteria. These various invaders are free to multiply and attack the person infected as if there were no protective white blood cells in the blood stream.

What was previously not scientific knowledge, but which the above experiments proved beyond a shadow of any doubt: it was at a certain temperature of the blood, all **HIV** would be driven out of the pockets of white cells into the blood stream. Via passing the "hot" blood stream and its freed **HIV** through a virus filter, the blood down stream would then be void of **HIV**.

This technique, of using such a blood circulating special apparatus wherein heating a person's blood and filtering out the **HIV**, allowed all the so-treated persons to be fully free of **HIV** with

then no threat of *AIDS*. Those persons were followed during the first 6 months after conclusion of the treatment, with all tests showing negative for *HIV*. Of course, the above procedure did not render any of the treated persons immune to further contact with *HIV* nor to *AIDS* thereafter. The VOA article made that very clear.

One way to reduce count in persons, of internal blood-stream-occupying viruses, including free *HIV* [not yet attached] is via an electrolytic battery-operated virus filter installed permanently in one's blood stream to therein convert all freely circulating viruses to harmless molecules. Such an installed device would reduce internal virus counts during epidemics. The internal device needs an EM activated on-off switch so as to allow live virus vaccines the opportunity to immunize the person, then the filter device is turned back on at a later time. The device's battery would also be charged from outside the person via EM.

### **On Questions This Observer Must Ask**

Why has the above specific *HIV* information, complete "removal" of *HIV* from persons having previously tested positive over an extended period of time, and so much other vital information, been classified as unavailable to the general public? You want this information from officials who have it? And you have their correct website address. You must also have their secret password. [I have put forth, my papers 15 and 16, to counter secret passwords placed upon treatments of one type of arthritis, calcium deposits, and upon "removal" of *HIV*.] And, why has this information not resulted in further R&D to perfect the apparatus and procedures to save lives? This information was scientifically generated many years ago at great expense.

In the name of Humanity and to save lives, government information classifiers ought to, by law, be required to make all vital information, under copyright, available to the general public and at the same time fund R&D to clear up any residual problems of older information and devices and to create new devices similar to Star Trek's "nanites".

I have published papers on hows and whys of certain designs and published papers on how to build apparatus to get at those certain critical problems the establishment refuses to discuss privately or publically. The scientific community and all of Humanity are in grave danger caused by those fostering and promoting secrecy in science. This secrecy now sets us back by about 6 years. It is up to the scientific community everywhere to oppose secrecy in matters of science before it gets far worse.

MRI is a typical example of decades of cover-ups, mistakes, intentional delays, refusal to recognize and timely approve the science. So many problems were also created by the system trying to keep NMRIS secret and simply experimental.
